2025 Membership Dues will be the same as this year (No \$2 increase by USAS) \$89 Premium Athlete: \$36 Administrative, \$89 Coach Non-Athlete. \$79 Non-Coach Non-Athlete (Officials and Other); \$5 Outreach Athlete and Outreach Non-Coach Non-Athlete; \$56 Seasonal Athlete, \$225 Annual Club and Organization; \$140 Seasonal Club and \$500 League. Dues include a \$1 technology fee. Transfers are \$15. **NOTE** USAS has recently determined that LSC can charge only one Non-Athlete membership fee for all categories of non-athletes. *i.e.* Coach Dues =Officials dues= Other Dues. The suggested Non-Athlete dues is \$84.

Meet Income: Based on prior year estimates. 2023-24 has exceeded expectations.

<u>All Star Copays:</u> The location of WZ Age Group Champs is unknown. Co-pays are estimates. Assumed that Zone 4 will host 2025 ZAM meet.

<u>54000 - Age Group:</u> The location of WZ Age Group Champs is unknown. Assumed that ZAM will be held in Zone 4. (transportation expenses are higher).

<u>54550 – Diversity Camp:</u> Sierra Nevada and Pacific will be working together to host a joint Diversity Camp.

<u>55000 – DDEI:</u> Pacific Swimming will pay the individual athlete membership fee for an Oakland Community Pool. Estimated amount is \$750 which will be absorbed into existing DDEI budget line items.

<u>57000 – Treasurer:</u> There will be a savings of \$236/month when we complete the required switch to Quickbooks Online (QBO). All transition expenses will be incorporated in the 2023-24 fiscal year.

<u>Events</u>, <u>Officials</u>, <u>Athlete Rep</u>, <u>Marketing</u>, <u>and Office Expenses</u> are based either on a submitted budget or prior year expenses. We have seen increased expenses across all expenses.</u>
